Reply from Trader: Firstly, thank you for saying that the work we carried out with regards what we were asked to undertake you were happy with. Secondly, as I said to you we don't undertake any type of drainage cleaning

under ground level. I totally sympathise with you about the blockage underground. However, the lesson in future is to have all under ground work carried out after the roof and gutter cleaning, as there is a possibility of the drains becoming blocked again, due to the amount of moss etc still in the gutters and on the roof. I understand you had the drains cleaned when you bought the property but between the drains being cleaned and Skyvac Services cleaning your roof and gutters there was a possibility of the drains becoming blocked again. It is standard procedure for Skyvac to block the top of the downpipes while the work is being carried out, once the roof has been cleaned we do make sure all gutters and down pipes have been cleaned out.
